Position Summary:

The School of Civil, Environmental and Infrastructure Engineering (SoCEIE) at SIU Carbondale invites applications for a full-time, continuing, tenure track faculty position in the area of Environmental Engineering at the rank of Assistant Professor.

Duties and Responsibilities:

- Teach undergraduate and graduate level courses as assigned by the school director.
- Actively participate in the senior design course.
- Develop an externally funded research program in environmental engineering. The school provides support and excellent opportunities for the development of new faculty.
- Carry out research and supervise the work of M.S., M.E., and Ph.D. students.
- Actively participate in scholarly activities by publishing the results of her/his research in peer-reviewed journals and conference proceedings.
- Collaborate with other faculty on research and professional development activities.
- Provide service to the school, college, university, and profession. This includes participation in international and national professional society activities.

Minimum Qualifications:

Applicants must have an undergraduate degree in Civil Engineering or a closely related engineering field and an earned doctorate in Civil Engineering or a closely related engineering field with a specialization in the area of Environmental Engineering by August 15, 2024. Applicants must have a demonstrated potential for high-quality research documented by publications and funded projects, and high-quality teaching for undergraduate and graduate courses in general Civil and Environmental Engineering fields. In addition, professional engineer licensure is desirable and will be required for tenure.

Preferred Qualifications:

Special consideration will be given to applicants with professional practice experience in industry and/or academia.

General Information:

Applicants must submit a cover letter which clearly describes the candidate's qualifications for the position, a complete vita, a teaching statement (maximum 2 pages, uploaded as document type "other"), research statement (maximum 2 pages, uploaded as "other"). Review of applications will begin December 1, 2023. Applications will be accepted after this date until the position is filled.
